CCMT-2013 Spot Admissions

The spot admissions for the vacant seats of M.Tech. programs offered by different departments of SVNIT Surat are going to be held on <u>30th July 2013.</u>

Only the following candidates are eligible for the spot admissions:

- 1. The candidates who have applied through CCMT but have not been allotted seats in any of the rounds.
- 2. The candidates who have surrendered their seats during the third round but have not been allotted seats in the fourth round.
- The candidates who have been allotted the seats in the fourth round but have withdrawn the allotted seats at the reporting centre during 23-26 July 2013. The candidates who have not withdrawn their seats during 23-26 July are not eligible for the spot admissions.
- 4. The candidates who have been allotted the seats but not reported in person to any one of the Reporting Centers within the scheduled time frame of the first 3 rounds. The candidates who have been allotted the seats in the fourth round but not reported during 23-26 July at the Reporting Centre are not eligible for the spot admission.

The GATE candidates who have not applied through CCMT are not eligible to participate in the spot round.

The vacant seats after the four rounds of CCMT admissions are going to be declared on the institute website on 27th July 2013. The candidates can have a look at the vacant seats before coming to SVNIT for the spot admission. They may come prepared to stay in Surat for 2 days (i.e. 30th and 31st July) and they may have to make their own arrangements for stay.

<u>The physical presence of the candidate is MUST and no representative is</u> <u>allowed.</u> <u>The candidates have to report to the respective</u> <u>departments during 9.00 am to 12.00 noon of 30th July 2013.</u> <u>No</u> <u>candidate will be entertained who reports to the department after 12.00</u> <u>noon and such candidate can not make any claim later.</u>

The departments will verify the documents and the allotment will be displayed by the respective departments on the same day (30th July) before 2.00 pm. The candidates who will be offered admission are required to pay the institution fees on the same day and report back to the department with the fees receipt (30th July). The departments will remain open up to 6.00 pm on 30th July.

The candidates who have been offered spot admission on 30th July but not paid the fees on the same day will forfeit the offer of admission and the department may offer the admission to the next candidate in the list in the morning of 31st July (the departments which are offering more than a single program may do internal sliding WITHIN the spot admitted candidates). The names of the candidates who have not paid the fees on 30th July will not be considered for the internal sliding. The candidates who have been offered admission in the morning of 31st July are to deposit the fees on the same day (31st July) and report to the department with the fees receipt before 4.00 pm. This completes the spot admissions and the vacant seats remaining, if any, will be displayed on the institute website on 01-08-2013.

The following <u>ORIGINAL</u> documents (and fees, if the admission is offered) are required to be deposited at the time of **physical reporting of the** candidates on 30th July 2013:

 Printout of the registration application form downloaded from the CCMT website (as a proof that the candidate had applied to CCMT in the month of May 2013)

- 2. GATE score card (2012/2013)
- 4. ID proof as per Govt. of India norms
- 5. Class X (High School) Board Certificate as proof of date of birth
- 6. All semesters Grade/Mark sheets of qualifying examination
- 8. Degree / Provisional certificate, if degree is completed
- Course completion certificate issued by the Head of the Dept./Institute (in the case of result awaiting candidates). In addition, they have to give an undertaking in the prescribed format.
- Certificate of category (OBC/SC/ST/), if applicable, issued by the competent Authority (OBC certificate must be issued on or after April 1, 2013.)
- 11. Undertaking by the candidate regarding OBC status in the prescribed format.
- 12. Certificate for Persons With Disabilities (PWD), if applicable
- Institute fees of Rs. 35,500/- (Rs. Thirty Five Thousand Five Hundred only) by cash or by DD. The DD should be drawn in favor of "Director, SVNIT, Surat" payable at Surat only).

Note:- If the original certificates are not in English/Hindi, Englilsh /Hindi version/ translation of such certificates will be required during physical reporting. **One set** of self-attested photocopies of the above-mentioned documents should also be submitted at the time of physical reporting.
