# APPOINTMENT OF JUNIOR ENGINEERS (ELECTRICAL) ON CONTRACT BASIS BATCH 2013

Madhya Pradesh Poorv Kshetra Vidyut Vitaran Company Limited, Jabalpur has been incorporated to undertake activities of distribution of electricity in the Eastern part of M.P. The Company invites applications from the eligible candidates for appointment of **Junior Engineer** (**Electrical - Contract**) as per the following details:

#### 01. RESERVATION:-

1.1 The reservation of posts meant for SC / ST / OBC shall be applicable only for the candidates having Madhya Pradesh domicile. Such candidates shall be required to submit a proof of Domicile in M.P State. For availing the benefits of reservation on the basis of Caste, the candidates shall be required to produce **Caste Certificate** issued by S.D.O (Revenue) of concerning jurisdiction. The candidates belonging to OBC category will have to produce **non creamy layer certificate**.

#### 02. CONTRACT PERIOD:-

- 2.1 It shall be **Three years** from the date of engagement on contract. The contract agreement shall be terminated automatically after completion of contract period of two years.
- 2.2 In case performance during contract period is found satisfactory, after a break of such period as decided by the Company, a fresh contract agreement could be made with mutual consent for a further period of three years.

#### 03. HOW TO APPLY:-

## Please read carefully:-

- **a.** Applications shall be received through M.P. online only. No application by any other means shall be entertained. To go online, please log on to the website **www.mponline.gov.in** to submit the online application format.
- **b.** Application fee for Unreserved / OBC category candidates of MP domicile and candidates of all categories belonging to other states shall be Rs.300/-. SC / ST category candidates of MP domicile are exempted from this payment.
- c. Rs. 60/- MP Online portal charge per application shall be charged from all candidates.
- **d.** No extra charge shall be payable for scanning of photograph etc. to Kiosk apart from the portal charges.
- **e.** The reservation is meant for SC / ST / OBC category candidates having Madhya Pradesh domicile only.

#### 04. EDUCATIONAL QUALIFICATION:-

The candidate should possess a diploma in **Electrical Engineering** or **Electrical and Electronics Engineering** from a University recognized by University Grants Commission or AICTE or Polytechnic or ITI, with minimum 60% marks in aggregate in case of **Unreserved or OBC** category candidates and 50% in case of **SC / ST** category candidates. Candidates having degree in same field may also apply.

#### 05. AGE LIMIT:-

The age of the candidates should not be less than 21 years and not more than 30 years as on 01/01/2013. Candidates belonging to SC / ST / OBC / widow / divorcee lady candidates, ex serviceman categories shall get relaxation in upper age limit to an extent of five years subject to production of proof.

#### **06. SELECTION PROCESS:-**

- 6.1 The selection of candidates will be done purely on **merit basis**.
- 6.2 The merit list (for the eligible candidates having minimum qualifying marks) will be prepared on the basis of marks obtained in (BE/B Tech) first and thereafter the merit list for the minimum qualifying (Diploma) shall be prepared (for the eligible candidates having minimum qualifying marks).
- 6.3 The merit list for JE (Electrical-Contract) shall be prepared in the following manner:
  - a) For **BE / B.Tech** or equivalent degree of candidates by taking the aggregate percentage marks obtained in degree up to two decimal digits after rounding off the third digit first.
  - b) Then in similar fashion the merit list for **Diploma holders** shall be prepared and placed below the last candidate of the merit list as (a) above.
  - c) If there is more than one applicant with the same cut off percentage then the merit list shall be prepared in order of date of birth in descending order i.e. the candidate having the same percentage but older in age shall be shortlisted first and thereafter the candidate younger in age but securing the same percentage shall be shortlisted next and so on.
  - d) Merit list will remain valid up to the financial year 2013-14.
- 6.4 The list of provisionally selected candidates for documents verification will be available on Company's website **www.mpez.co.in**. The availability of same will be notified in leading daily news papers and on website of MP Online.

#### 07. REMUNERATION:-

The Junior Engineer (Electrical - Contract) shall be engaged initially on a lump- sum consolidated monthly honorarium of Rs. 15,000/- per month plus Rs.400/- per month mobility allowance and Rs.400/- per month communication allowance. The honorarium may be increased by 10% after one year of contract period, depending upon the performance of the person engaged on contract. The minimum statutory employer's contribution towards New Pension Scheme shall be exclusive of above.

#### 08. TRAINING:-

The selected candidate will be given three month training. During of training, the Junior Engineer (Electrical Contract) shall be subjected to a written test and upon qualifying this exam (min 50% marks) the contract shall be continued.

#### 09. GENERAL CONDITIONS:-

- a) Candidates working in the Government / Semi-Government / Public Sector satisfying the eligibility criteria of education and age shall have to produce **N.O.C.** at the time of **verification of documents**, failing which their candidature shall stand cancelled.
- b) The reservation for SC / ST / OBC category shall be applicable for candidates having M.P. domicile certificate only.
- c) Any dispute arising out of the selection process will be dealt with in the jurisdiction of courts situated only in **Jabalpur**.
- d) The candidates must produce original documents / certificates at the time of verification of documents in support of their qualification and experience.
- e) The engagement on contract basis is purely temporary in nature for specific period (three years) as mentioned.
- f) The candidate shall be required to work anywhere in the jurisdiction of MPPKVVCL, Jabalpur.
- g) Since the nature of job requires monitoring of field activities, the candidates must possess sound health.
- h) The candidates who have a third child born on or after 26.01.2001 are not eligible to apply.
- i) While submitting the application form online, candidates should invariably submit their email ID and cell / landline number. The Company shall not be held responsible for non receipt of any communication at the e-mail ID, cell / landline number submitted by the candidate.
- k) If any of the information given by the candidate is found incorrect, his / her candidature will be cancelled at any stage of selection and appointment.

#### 10. LAST DATE OF SUBMITTING ONLINE APPLICATION:-

Applications can be submitted online only through M.P. online site (www.mponline. gov.in) up to midnight of 20.07.2013.

#### 11. DOCUMENTS:-

Documents to be furnished in original at the time of verification of documents alongwith one set of photocopies attested by a Gazetted officer and a copy of online submitted application form / Receipt:

- (i) Certificate of Graduation Degree / Diploma / ITI in Electrical Engineering or Electrical and Electronics Engineering.
- (ii) Each Semester / Year **Mark sheet** of Graduation Degree / Diploma / ITI in Electrical Engineering or Electrical and Electronics Engineering.
- (iii) 10th Board exam Mark sheet as proof of date of birth.
- (iv) 12th Board exam Mark sheet.
- (v) NOC from present employer, (If serving in any Govt. / Semi Govt. / PSU / Local bodies).
- (vi) **Proof** for availing benefit of age relaxation / reservation.
- (vii) Caste certificate for SC / ST / OBC category candidates. OBC category candidates will also have to produce non creamy layer certificate.
- (viii) MP Domicile certificate for SC / ST / OBC category candidates.
- (ix) Copy of address proof of candidate.
- (x) Copy of **ID proof** of candidate.
